DIRECT DEBIT SERVICE AGREEMENT

By making this Direct Debit request, you have authorised the AMWU to arrange for funds to be debited from your account to cover your Union Dues.

Please note the following important points:

- Direct debit is not recommended for AMWU members whose employment is irregular i.e. casual, seasonal or contracted employees.
- You may need to make sure that there is enough money in your nominated account to cover the debit. If not, you may incur a fee or charge from your financial institution. If your debits repeatedly fail, your direct debit service agreement may be cancelled and an invoice sent for payment instead.
- Please make sure your account details are correct by checking them against a recent bank statement.
- We will keep your account details confidential unless required by law or to determine any query regarding your account.
- If you wish to stop, vary or cancel this direct debit authority, or an individual payment, you can:
 - call the Membership Department in your branch
 - write to your State Secretary
 - email the AMWU Helpdesk at amwu@amwu.org.au

Requests for variation or cancellation may take up to 14 days to take effect.

- If the debit is scheduled to fall on a day which is not a business day, your account will be debited on the following business day.
